Duration of the audit: Pursuant to the Work Plan of the Auditing Commission for the corporate year 2024–2025 (Minutes of Meeting of the Auditing Commission of JSC Rosseti Kuban No. 1 dated 2 July 2024), the audit of the financial and business activities of JSC Rosseti Kuban for 2024 was conducted in the period from February to June 2025.

Grounds for the audit: Federal Law No. 208-FZ dated 26 December 1995 On Joint Stock Companies, Articles of Association of JSC Rosseti Kuban, Regulations on the Auditing Commission of JSC Rosseti Kuban, Resolution of the Auditing Commission of JSC Rosseti Kuban (Minutes of Meeting No. 1 dated 2 July 2024).

Objective of the audit: To audit the economic and financial activity of JSC Rosseti Kuban, to confirm the accuracy of the data contained in the Annual Report for 2024, the accounting (financial) statements of JSC Rosseti Kuban for 2024 (hereinafter – Statements).

Reliability in all material respects means the degree of accuracy of the data in the Statements, which allows the shareholders to draw correct conclusions about the results of business operations, financial and property position of JSC Rosseti Kuban, and to make informed decisions based on such conclusions.

In accordance with Federal Law No. 208-FZ On Joint Stock Companies dated 26 December 1995 and the Articles of Association of JSC Rosseti Kuban, the executive body of JSC Rosseti Kuban is responsible for organisation, condition and reliability of the accounting process at JSC Rosseti Kuban and timely submission of accounting (financial) statements.

Audited period: 01.01.2024 to 31.12.2024.

Object of the audit: Annual Report for 2024, accounting (financial) statements for 2024, resolutions of management bodies, local regulations and organisational and administrative documents of JSC Rosseti Kuban, roadmaps, accounting registers, primary accounting documents and other documentation of financial and economic activities of JSC Rosseti Kuban.

11. SUMMARY

The audit examined the Company’s compliance with the legislation of the Russian Federation and the local regulations of the Company.

The Auditing Commission selectively audited a number of financial and business transactions of the Company for accurate and timely recording of the facts of business life in the accounting and financial statements for 2024, the reliability and completeness of information disclosure in the annual report for 2024.

In evaluating the reliability of the accounting (financial) statements for 2024, the Auditing Commission relied on the opinion of the Company's auditor, LLC Audit Technology and Solutions Centre – Auditing Services (TsATR – Auditing Services)

(member of the self-regulated organisation of auditors Association Sodruzhestvo, ORNZ 12006020327), expressed in its auditor's report dated 17 March 2025.

In the opinion of the Company's auditor, LLC TsATR – Auditing Services:

Accounting (financial) statements present fairly, in all material respects, the financial position of the Company as at 31 December 2024, as well as its financial performance and cash flows in 2024, in compliance with the Russian Federation rules for accounting (financial) statements.

In the Emphasis of Matter section, the Company's Auditor LLC TsATR – Auditing Services specified the following:

We draw attention to paragraph 24 Events after the Reporting Date of the notes to the balance sheet and the statement of financial results, namely that on 24 January 2025 the Company changed its name from Public Joint Stock Company Rosseti Kuban to Joint Stock Company Rosseti Kuban. We do not express a modified opinion on this matter.

The accounting (financial) statements are prepared in accordance with the laws and regulations of the Russian Federation and local regulations of the Company, in all material respects.

During the audit, the data of the annual accounting (financial) statements and the data of the Company's annual report for 2024 were selectively reconciled. As part of the work done, the Audit Commission did not find any material misstatements of the financial information contained in the Company's annual report for 2024. At the time of issuing this Opinion, the Company's annual report for 2024, submitted for approval by the Annual General Meeting of Shareholders, has not been approved by the Company's Board of Directors.

No facts of violation of legal acts of the Russian Federation in the course of financial and economic activities, which could materially affect the Company’s Statements, were revealed in the course of the selective review, were identified.

Pursuant to Article 88 of Federal Law No. 208-FZ dated 26 December 1995 On Joint Stock Companies, the Auditing Commission shall, based on the results of the audit of the Company's financial and economic activities for 2024, express an opinion on the reliability of information, in all material respects, contained in the Company's annual report for 2024 and annual financial statements for 2024.
